The Society believes it has appropriate support for any tax positions taken affecting their annual filing requirements, and as such, do not have any uncertain tax positions that are material to the financial statements. The Society would recognize future accrued interest and penalties related to unrecognized tax benefits and liabilities in income tax expense if such interest and penalties are incurred. For federal tax purposes, the tax returns essentially remain open for possible examination for a period of three year after the date on which those returns are filed.
